Review Board's representative in the call: Dave MontagueDescription of the Call Date: 04/12/96Subject: Possible New Garrison Investigation PhotoSummary of the Call: I was contacted by Francesco Ruffa of New Orleans based on his reading an 04/09/96 article re: the Review Board and Investigator Gurvich of the Garrison case. Ruffa claims to have a photograph of Dealey Plaza which he believes to be related to the Garrison case. The photo is in black & white and encased within a pine frame weighing approximately 25 pounds. The back of the frame has a stamp with the words: "New Orleans Parish District Attorney Office April 1966" and a signature which Ruffa believes to be Gurvich's is present. At least one side of the frame has the initials: "J.G." written. Ruffa seemed to be probing for any relative importance of the photo and mentioned that other people whom he only identified as collectors are interested in acquiring the photo. He said he acquired the photo at a garage sale some time ago but could only say it was within the last year. He could not provide the location of the garage sale except that it was in the New Orleans area. I explained the nature of the Review Board and asked if he would be willing to donate the photo to the Collection if it can be authenticated to which he said he will consider. He did say he agrees that all records should be placed in the Archives as opposed to any other museum of less recognition. I thanked him for his quick response to the article about the Review Board and for his interest and told him I will send him a letter and info packet for his review and we can continue negotiations from there.
