Description of the Call Date: 06/11/96Subject: Deposition Date for John StringerSummary of the Call:I called John Stringer today to arrange a date for his deposition. He agreed to the following:July 15, 1996: Fly to Washington from FloridaJuly 16, 1996: Deposition at Archives IIJuly 18, 1996: Fly Back to Florida His daughter lives in Potomac, Maryland, and he will stay with her, so we will not have to pay for a hotel. He requested that we purchase the plane tickets and mail them to him ahead of time, and I promised we would do that, along with written confirmation of the above schedule, and a map of how to get to Archives II. I will send a separate e-mail to Tracy re: travel arrangements with more details. The above schedule is within the acceptable window which I received from Jeremy. One thing he said disturbed me. Mr. Stringer was very cooperative and agreeable about coming to Washington, except for the beginning of the phone call when he was under the impression that we were associated in some way with author Harrison Livingstone. I told him we were not, and asked him why he thought that, and he said that Mr. Livingstone was in frequent contact with him in attempts to get Stringer to submit to interviews, and that in this context Mr.Livingstone had given him the strong impression that he was either working with, associated with, allied with, or otherwise close to the Review Board and Judge Tunheim. I assured Mr. Stringer otherwise by explaining the structure of the Review Board and Staff, and explaining that Judge Tunheim has answered some of Livingstone's letters, just as he has answered the letters of all researchers who have written him. After assuring Mr. Stringer of the Review Board's neutrality and agnostic position on the assassination, he became quite amenable to scheduling the deposition. END
