Review Board's representative in the call: Dave Montague Date: 07/18/96Subject: Initial conversation w/ Velma Reumann of the Naval Photographic Center (NPC)Summary of the Call:Medical Project I spoke with Reumann today, identified myself & explained the purpose of the Review Board. Reumann was cordial & confirmed that she is the same Lt. V.R. Vogler (now Reumann) who was the Personnel Officer of the NPC at Anacostia in 1963. I did not get into any specifics about why the Review Board wants to speak with Reumann except for the fact that we're interested in her knowledge of the NPC at that time. She said she certainly remembers her role & is willing to answer any questions asked of her. I informed her that she would receive an information packet re: the Review Board in order to increase her familiarity. After more discussion about the JFK Collection, Reumann said she was working at the NPC the day of the assassination & remembers there was a White House photographer (assigned to the NPC at that time) who was sent to Dallas with JFK. His name was Lt. Tom Atkins & she remembers he made pictures of him in Dallas, but doesn't think of the assassination itself. Reumann said "...his material should be at the NPC, in the archives...".
