Review Board's representative in the call: Dave MontagueSubject: Conversation w/daughter Marilyn Buckler re: Martin Paul MacNair of the NPCSummary of the Call:Medical ProjectI spoke with Buckler today & she said her father died on 10/01/92 (not 1994) as her brother told me. I explained the nature of the Review Board to her & explained that her brother recommended I speak w/her in order to find any possible papers that their mother may have relating to MacNair's career or the assassination. Buckler said her father would never bring sensitive papers home & never discussed his work with them. She only knows that he had a great deal of responsibility while in the Navy. I told her we are trying to find out if any papers re: the NPC relating to the assassination exist & can be placed within the Collection. She doesn't know of any records or papers that her mother may have, but said it is ok to contact her mother to make sure.Buckler asked numerous questions re: the location of the Review Board & said she found it strange (based on her experience working for the U.S. Department of Veterans Affairs) that I was able to conduct interviews over the telephone rather than in person; she felt uncomfortable dealing with such questions over the phone. I explained that I was familiar w/ doing such interviews in person when I was with the DEA, but given our limited resources & time span to accomplish so much, it is not always an option to do such interviews over the phone. I informed her that I usually follow all interviews with an information packet so people will feel comfortable dealing with us. I apologized for any discomfort she felt & offered to send her such an info pack to which she said she'd be appreciative.
