Review Board's representative in the call: Dave MontagueDescription of the Call Subject: Initial contact w/ Chester Boyers re: JFK's autopsyMedical Project I found Boyers living in Virginia, identified myself & explained the nature of the Review Board. After my explanation, he confirmed he's the same Boyers who was a Navy Chief PettyOfficer in 1963 & present during the autopsy of President Kennedy. Boyers was very attentive to my explanation about the Board & its efforts, but wanted me to know that he needs some additional credentials & did not want me to be insulted because of his"lack of trust" in talking with me over the phone. He then said: "...I've been bullshitted for too many years on this thing... I don't feel like dealing with a bunch of researchers or other types who'll just say one thing & write another...". I responded by saying that many people are cautious re: discussing the assassination & that I wanted him to be as comfortable with my call as possible & in any dealings with our agency. I then reiterated that we're the 1st federal agency of our unique nature to be established. I alsoexplained that numerous people associated with the assassination have preferred to deal with us because their contributions will be available to the public through the Archives, creating less need for people to contact them in the future. At this point, I offered to send to send him an information packet. He said he'd look it over & decide what he wants to do.I asked to leave the door open for an interview by a member of our staff after he's reviewed thematerial, to which he said: "I really don't have anything to add to any record...After all that WC & other stuff, don't they have enough to be done with this?". I said our staff may have some relevant questions pertaining to the Record. I verified his address & thanked him for his time.* I'll send an info packet & copies to the Medical Team for further action.* It is highly recommended he be visited in Virginia.Boyers' information is:Chester H.
