In June theState Department Advisory Committee on Historical DiplomaticDocumentation passed a resolution that made clear the committee'sdeep concern about "the tendency of Congress and various federalgovernment agencies, particularly the Central IntelligenceAgency, to allocate resources to the declassification review ofdocuments relating to specific and selected historical topics."The committee advocates that limited resources be directed towardsystematic declassification review which respects the integrityof historical context and archival principles. While releasingcertain selected documents creates the illusion of openness, thecommittee notes that "targeted" openings become a form ofinformation control.
