His travel plans are as follows:-Nov 21, 1996: Fly from Redding, CA (local airport in close proximity to his home) to DCA;- Stay in a hotel (to be arranged by ARRB) close to, or easily accessible to, Review Board P.M. Nov 21st;-Meet with ARRB for interview at 9:30 Friday, November 22, 1996 for an interview of approximately 2 hours;-He will fly out of DCA to Buffalo for personal business (to visit his parents) mid-afternoon that same day (Nov. 22nd);- He will fly from Buffalo to Redding, CA (return leg of his ARRB travel) on December 3.My Action: I will certify to David Marwell, by memo, that Mr. Madonia's arrangements were less expensive than govt fares for same dates (I have information obtained from SATO);Tracy, Request Your Help With the Following:-Please arrange reservation at local hotel (govt rate) convenient for this purpose...I suggest Crystal City...advantages are that it is near DCA, and will allow him to take yellow line metro directly to ARRB without transfer;-Please prepare Invitational Travel Orders for Vincent Madonia, SSN: [Screened by: NARA RD-F on October 24, 2016 according to the John F.
