Review Board's representative in the call: Ron HaronDepartment of the Treasury's representative in the call: Irving WilsonDescription of the Call Date: 12/23/96Subject: Main Treasury ComplianceSummary of the Call:Irving Wilson called in response to our December 19 letter in which we asked Treasury to identify and locate a number of main Treasury files that may contain assassination-related materials. He indicated that he was not the appropriate official to whom the request should be directed, although he would assume responsibility with Steve Milline for following up on the letter. I pointed out to him that he was identified as the contact person for main Treasury per Jane Sullivan's [June 7, 1995] letter. He said that he was the designated contact for Main Treasury as overseer of the constituent bureaus but not with respect to Main Treasury records themselves (I have neither heard of nor seen that distinction and the Sullivan letter does not make that distinction). He first said that Steve Milline was the appropriate person for Main Treasury records; later in the conversation, he indicated that Main Treasury records (e.g., Secretary of the Treasury) fall under the jurisdiction of "DO" (Departmental Offices) and the highest official for that group is a Mr. Rodriguez (I believe that Mr. Wilson was referring to Alex Rodriguez, Deputy Assistant Secretary for Administration). I told Mr. Wilson that he has to work out any intra-agency issues but that we expect there to be a person who assumes responsibility for Main Treasury compliance, whoever that may be. Mr. Wilson indicated he would assume responsibility for following up on the letter, and I said that he or his boss Constance Drew could call me with any questions. This lack of clarity regarding the responsible official underscores the importance of sending a compliance letter to the Secretary of the Treasury, which I will draft. Unless Treasury indicates otherwise, we should continue to regard Mr. Wison as the responsible person per the Sullivan letter. Don't forget to compose individual Action Item documents for any action items that resulted from the call!
