Student Directorate in New Orleans. He is alleged to have been in a scuffle with LHO during August of 1963  
when Oswald was passing out FPCC literature. A source references a CIA Memo (502, P. 3), which indicates  
past contacts between CJB and Clay Shaw. The same source notes that representatives Dwyer & Greissing  
(SSCIA) of the Church Committee interviewed CJB on 01.12.1976. New information indicates subject known as  
"Carlos Jose Bringueir, Sr." was born [Screened by: NARA RD-F on October 24, 2016 according to the John F.

This business (his condominium building) is located at 16850 South Glades Drive in North Miami Beach, FL  
33162-2909 & has a phone listing of 305.947.6242. It holds Florida #714823, which is listed as "active".  
Sources also associate CJB w/: 319 Terry Parkway in Terrytown, LA 70056 (504.362.4521). I have info  
concerning numerous relatives if needed. I found no liens, judgments or bankruptcies during my  
research. \*Manuel & I plan to call CJB on next Tuesday re: the disposition of a military manual associated  
w/LHO & any possible records from his association w/the DRE (an Anti-Castro organization). ~end~
