Here is the necessary information: Donor Gerald Nathan Taplin, Sr.Description of DonationA videotape copy of a two minute 8mm film taken on Commerce Street outside of the Dallas Police station on the morning of November 24, 1963 when Lee Harvey Oswald was shot by Jack Ruby inside of the station. Special Provisions1. The donor and David Taplin (his grandson with whom I have been dealing) will retain the copyrights to the film. Using the Doyle deed of gift language as a model, what they would like to do, if possible, is have the donor and grandson David Taplin retain life estates in the copyrights to the donated material.
