We reviewed the contents of the Navy's Initial Statement of Compliance, dated March 25, 1997; in that letter, the Navy's General Counsel Office had given it's subordinate elements until April 30, 1997 to report on the results of searches. We reviewed the status reports received to date from SECNAV, CNO, and ONI. Navy JAG and the Navy Historical Center are still working on responses. All parties agreed that per previous informal discussion, the Navy's General Counsel Office would give the Marine Corps until August 30 to complete its search. Accordingly, Mr. Haron then revised the due date for the Department of the Navy's Final Compliance Statement to approximately September 15, 1997.Mr. Horne reviewed the requirements of the JFK Act in regard to declassification review standards (i.e., Section 6), and creation of identification aids (RIFs). Horne promised that the ARRB staff would obtain USMC and Navy RIF discs from NARA and pass these to the Navy General Counsel's Office, to facilitate that process.Mr. Haron will memorialize the results of this meeting in much greater detail in a forthcoming letter to the Navy's General Counsel Office which will serve as detailed minutes to the meeting.
