Review Board's representative in the call: Ron HaronResearch Community's representative in the call: Curt GentryDescription of the Call Date: 05/29/97Subject: FBI RecordsSummary of the Call:I spoke with Curt Gentry today to set up a time when we could speak with him about certain issues involving FBI records and any insights he may be able to provide us. Although my intent was to merely set up a time to speak with him, we did get into substantive issues and there is probably no need to interview him further. In general, Mr Gentry did not provide any concerete, new information on FBI records. We touched on the following issues:1. Alleged Hoover taping system -- Gentry has never been able to pin this down and provided no information beyond what is in his book.2. William Sullivan records -- Gentry does not know what ultimately happened to them. He recommended contacting Bill Brown, who assisted in writing William Sullivan's memoirs. Gentry also noted that Sullivan had some sisters, who we perhaps could try to contact.3. John Mohr/Clyde Tolson Records -- Gentry added nothing further to his book, noting that no one really knows what records they may have taken. Gentry mentioned Robert Fink as someone we may want to contact on the Hoover files issue generally. Mr Fink worked on Bella Abzug's Committee which looked into the disposition of the Hoover files (Mr. Fink's number is 914-359-6135 and fax is 914-359-3651; his address is 271 River Road Grand View on the Hudson, NY, NY.). 4. Alan Belmont -- Gentry interviewed him and did not get much out of him (Belmont is now decesed)..5. JFK Assassination Records -- I asked Gentry whether he was aware of any records within or outside the FBI organization relating to the JFK assassination that we should be pursuing. He had no suggestions. 6. Person Familiar with Hoover's Record Keeping -- I asked Gentry whether he had interviewed, or knew of , any secretary or administrative staff who was familiar with Hoover's record keeping practices. Gentry mentioned Tolson's secretary .7. Other FBI Officials to Talk to -- Gentry mentioned two other agents we might want to talk to. Gentry indicated these agents were ant-Hoover, but gave no indication that they had any specific knowledge regarding FBI records on the Kennedy assassination. (Their names and numbers are Bill Turner, 415-479-7945, 163 Mark Twain Avenue, San Rafael, CA 94903 and Wes Swearingen, 602-825-7042, 3712 S. Ridgefield Blvd., Tucson, AZ 85737).8. Bill Sessions -- Mr. Gentry also offered to put us in touch with former FBI Director Sessions if we would like, but Gentry again offered no information that Mr. Sessions would have unique knowledge regarding FBI records on the Kennedy assasination (however, in connection with the passage of the JFK Act, Mr. Sessions did testify before Congress in 1992 regarding FBI records on the assassination, particularly as processed under FOIA).
