I talked to Jeremy on Tuesday about what he wanted you to do on the Sheridan issue. He said that he has no new information for you, but that he would like for you to write a comprehensive memo on the Maryland privilege. I asked Jeremy whether he wanted you to include a discussion about the Federal constitutional privilege (to the extent that it exists or whatever. . .), and he said that you should finish your Maryland memo first and then, if you think that you have enough information to write a second comprehensive memo on waivers in the First Amend. context, you should start to write about that. He'll be back in the office tomorrow (Friday.) I would like to talk to you more about the IRS work that I gave to you and I hope that we will be able to touch base sometime tomorrow.I do have a third assignment involving the FOIA that I could pass along to you, which I would be happy to do, but I suspect that it will take you a few days to finish work on the Sheridan memo. Reg. 301.6103(a)-1: Found no amendments to the version you copied for me. Found a few circuit cases, indicating that: 1) defendants have rights under 6103(h)(5) to inquire about tax audits during prosecutions in order to discover information allotted to government agencies under 301.6103(a)-1;2) 301.6103(a)-1 is a "companion piece" to 26 USC 6103 which is aimed at curtailing abuse by government agencies of information filed with the IRS but which is not a general prohibition.What should I do next?
