Review Board's representative in the call: Douglas HorneUS ARMY Central Security Facility's representative in the call: Elaine RogicDescription of the Call Date: 07/18/97Subject: Elaine Rogic Called Doug HorneSummary of the Call:Elaine Rogic, Director of IRR, called me today to say that the Central Security Facility has been disestablished, and that Jane Sealock (its director) will be retiring from civil service soon.She said that IRR has now become part of the 716th Military Intelligence Battalion. The formal mailing address is:Commander, 716th Military Intelligence BattalionAttn: IAMG-C-CO4553 Pike RoadFort Meade, Maryland 21227-5998The name of the Commanding Officer is: LTC Michael D. Bisacre, USAShe said she had briefed him on the work IRR has done, and is doing, in response to the JFK Act and ARRB requests. He is concerned about the arrangement made between Tim Wray and IRR for the ARRB (not IRR) to have the responsibility for pursuing IRR's referrals with other agencies for the approximately 34 case files in the IRR's HSCA sequestered collection. He desires, she said, for ARRB's Executive Director to sign out correspondence to him memorializing this arrangement, so that there is no misunderstanding as to action or responsibility.I told her that my supervisor (Jeremy Gunn) and I were discussing how to pursue this matter--i.e., whether to continue the arrangement made between her and Tim Wray (and subsequently agreed to by me), or whether ARRB should pull all of the documents out of IRR and place them in our SCIF (i.e., take custody after IRR had completed its own declassification review), and then direct all referrals to come directly to ARRB following review by referral agencies. Under this alternate scenario, ARRB would then be responsible for marrying up the base documents received from IRR with the processed referrals, and submitting the documents to NARA following Review Board consideration. I said that we would have to discuss strategy on this issue further here at the ARRB, and that once a final decision was made on how to proceed, we would then memorialize it with a letter to her CO.She said her preference would be to "see this through to the end," i.e., receive the processed referrals back at IRR, consolidate the referral postponements with their own, and then transmit them to us. But she said she would consider the other option, and discuss it with me further in a week or two. I told her I was sure we would discuss this further with her before any letter goes out. ENDDon't forget to compose individual Action Item documents for any action items that resulted from the call!
