David asked me to rearrange for September. Purpose: to discuss ONI/NIS post-defection investigation of Lee Harvey Oswald circa 1959/1960. I spoke with Fred Reeves Friday, and he indicated his travel desires as follows: Fly from San Diego to DC (National Airport) on Sunday, September 14th; Personal day (day off-not on per diem) on Monday, September 15th; Day-long (for per diem purposes) meeting with ARRB staff on Tuesday, September 16th; Personal day off in Washington (not on per diem) on Wednesday, September 17th; Open return date on his ticket (National Airport to San Diego). He has requested that we arrange a suitable hotel reservation (King Sized bed...he may bring his wife with him at his own expense) for September 14th (check-in) September 18 (check-out) which is reasonably close to our offices. He understands that he will pay for hotel and per diem expenses up-front, and get reimbursed later. However, he DOES want us to FEDEX him his airplane ticket and orders ahead of time; he requested United Airlines if at all possible.
