O'Neill, Jr. formerly of the FBI Description of the Call \_\_\_\_\_ I spoke w/ a O'Neill on last Friday who confirmed he's the former FBI employee who was present during the autopsy of President Kennedy in 1963, after I answered several of his background questions re: my identity. We discussed how the assassination is still of great interest after 33 years and the vast number of records which the public will have access to due to the Review Board's efforts. After further explanation re: the nature of the Review Board, O'Neill agreed to our calling him for an in-depth interview. He wanted to know what we are interested in talking w/ him about & I said probably his involvement during President Kennedy's autopsy, among other things; he said that would not be a problem. I told O'Neill I'd send him a packet of explanatory information so he'll become more familiar w/ the Review Board in preparation for the interview; he said that'll be fine. I verified O'Neill's information & thanked him for his time. Mr. Frances X.
