She informed me that any correspondence regarding the referral of records should be addressed to Anne Winner. I stated that Douglas Horne of ARRB staff told me that it was his understanding that all correspondence to DIA was to be routed through her office, and that I had called her because I was unsure about referral procedures. She went on to say that it was up to us as to how we wanted to address the referral letter, however, she could not guarantee a timely response to our request if we sent the items directly to Ms. Winner. She seemed to recommend that we address our referral request to the Director, DIA -- doing so would guarantee that a tasking order is generated through the Executive Secretariat and passed on to Ms. Winner. Kennedy Records Collection Act of 1992, 44 U.S.C. 2107, Section 6(1)A] than stated that if we followed the latter procedure, she could guarantee that we would get a prompt response.I guess I would recommend that we send a letter indicating that we are in possession of NSA docs with DIA equities to the Director, DIA, w/o attaching the documents. That way a tasking order for Winner would be generated. Only then would we actually get together with Winner to review the documents. ENDDon't forget to compose individual Action Item documents for any action items that resulted from the call!
