I would suggest that it be a day-long discussion among>a group of experts who could make suggestions about possible>recommendations that the Board might make in its final report. Forreasons of cost and convenience, it would be useful to schedule theconference in conjunction with a regularly scheduled Board meeting.>>I would like to propose that the conference be held on Monday, April 13,>the day before the regularly scheduled Board meeting. (Easter is on April>12.) If you would like to attend such a conference, please let me know>promptly if April 13th works with your schedule. If not, is Wednesday,>April 15th acceptable?>>I would also like to hear your suggestions for people who might be invited>to attend. I mentioned to you that David Garrow is very interested and>that I think he would be a good addition. For the most part, it would be>helpful (for cost reasons) if the invitees are from the Washington area.>
