TynesDescription of the Call Date: 01/14/98Subject: Chris Tynes Called Doug Horne About ONI ComplianceSummary of the Call:LT Chris Tynes called me today to say that although ONI had previously anticipated completing its work under the JFK Act by January 30, 1998, that they had run into a few delays in conducting declassification review of the assassination records they hold (author's note: i.e., the defector files shown to ARRB staff in April of 1997) because of third agency equities. He said that ONI had scheduled a meeting between ONI and these third agencies at ONI, between Feb 2-4, inclusive, in order to conduct declassification review of these records. (I told him this was good news, and seemed to me to be real progress.) He also told me they were proceeding with the creation of RIFs for the documents, and said he knew they had a petty officer working on it.I told LT Tynes that an E-5 at ONI, Petty Officer Abercrombie, who had been working with LCDR Pike originally last Spring on JFK matters, had asked for guidance on how to prepare RIFs. Last week Jim Goslee and I invited her to a meeting at the ARRB in which we were going to answer all of her questions and provide training on how to create RIFs; she called back and cancelled out, saying that she "had been told she was no longer working on JFK matters," or words to that effect. She named LCDR Glass as the person taking over from her: (301) 713-6612, ext. 244.LT Tynes told me today that his POC at ONI was LCDR Glass, and that LCDR Glass worked for LCDR Bastien; he said they are both JAG officers.I asked him if he had received our letter of January 8, 1998 to his boss, Lt. Col. Finnie (sent before we heard from LCDR Abercrombie about a P.O.C.), requesting that his office facilitate an ARRB-ONI meeting, and he said no, so I faxed it to him after our phone call.[Author's note: presumably, Navy General Counsel will set up a meeting between ONI and ARRB which will include LCDR Glass. However, if the meeting that Finnie and Tynes set up does NOT include Glass, I will contact him anyway and inform him of whom we are meeting with.] ENDDon't forget to compose individual Action Item documents for any action items that resulted from the call!
