Tom -- Here is the FBI team update on our activities since January 23, 1998. The FBI team has negotiated 28,818 pages of records from the HSCA subject files with the FBI. The HSCA subject files that have been through the negotiation stage include Candy Barr, Dominick Bartone, Edward Browder, Jr., Dino Vincent Cellini, Rogelio Cisneros Diaz, Cesario Diosdado, Laureano Batista Falla, Joaquin Godoy y Solis, Alberto Hernandez Hechevarria, William Herman Jackson, Milton Jaffe, Paul Roland Jones, J.U.R.E., Marvin Kantor, Richard Lauchli, Anthony V. Martinkus, Priscilla McMillan, Lewis McWillie, M.I.R.R., Murray Miller, John Martial Murret, Ricardo Morales Navarette, Eduardo Perez, Nicholas Petrulli, Reinaldo Pico, Natalie Ray, Norman Rothman, Jean Souetre, Frank Sturgis, Oscar Contreras Valazquez, Antonio Cuesta Valle, Antonio Varona, Igor Voshinin, Mrs. Igor Voshinin, Eduardo Whitehouse, and Steve Wilson. In early February, the Review Board staff recommended that the FBI process additional records as assassination records under the JFK Act. Critics, including Weisberg, Thompson, and Meagher, FBI file references to Warren Commn. Staff, including Rankin, Ball, Hubert, Belin, and Goldberg, H.L. Hunt, Nelson Hunt, Lamar Hunt, and Paul Rothermel. I am going to ask Kevin to send you the final number of green documents and consent releases from the February meeting.
