	JFK LibraryAs you are aware, I submitted a memorandum that provided the current status of records at the JFK
	Library. Irene has a copy of this memorandum. In addition, I have met with her and we have discussed the
	status of all matters related to the Library.II. Private DonationsThe following is an update on all of the private
	donations with which I have been involved and that are pending. 1. Alyea Film - After Steve Tilley provided us
	with the information that he received from Alyea, in which Alyea asked NARA to give him back the film
	because he was donating it to the Sixth Floor Museum, we received assurances from NARA that they would
	not do anything with the film until advised by the Board. As you will recall, part of the original arrangement
	was that Alyea received a "positive" and a "negative" copy of the film, which he still has in his possession. A
	decision will have to be made on what to do regarding the Alyea film. As it stands now, it is in a kind of limbo
	because I do not believe that NARA allows researcher access to it. 2. Taplin Film - David Taplin has signed a
	deed of gift, which Laura has sent to NARA. NARA raised some questions about the deed of gift, but Laura
	thought it would be resolved. Archivist Carlin had not yet signed it the last time I spoke to Laura, but that may
	have changed. Although Taplin retains the copyrights, he was not opposed to some type of limited news
	broadcast availability. However, I do not think that the media would be that interested, although some
	researchers may express interest in it. I recommend, and have advised Eileen, that when Laura clarifies the
	status of the deed of gift with NARA, we send all the copies that we had made (and which are in Tracy's safe)
	to NARA and put a paragraph in a records release advisory about it. 3. Tyler Tapes- We still have all of the
	tapes that Steven Tyler dubbed for us in connection with his documentary, along with a copy of the documentary. We recently sent the final deed of gift to Tyler and I believe that we are waiting for him to sign
	it and send it back to us. He should be contacted about the deed of gift. Once he signs the deed of gift and
