The items include:
1. David and the NBC matter. David had thought he would be able to get back to me by last Wednesday, but I have not heard from him. I have left a message this morning asking him to call. If he can do it, you and I should discuss the proposed settlement arrangement. We have a status conference scheduled for the 9th before Judge Jackson.
2. Irene. We will be sending a draft letter for you. I think it would be effective to use your judicial stationary if you think that would be appropriate.
3. C-Span has proposed, albeit vaguely, scheduling an interview for its Morning Journal. What is your availability for Monday, Tuesday, or Wednesday of next week?
4. We have scheduled a deposition for the Sixth Floor Museum in Dallas on April 22. I would like Ron to do it. I also have some concerns about sending him into the lion's den. I have not yet had the time to complete the Goodpasture deposition. I think it makes sense for Ron and me to go to Dallas for two days. We would both participate in the Sixth Floor deposition, and I would complete Goodpasture's deposition on the preceding or following day. Ron could talk to the NARA office in Ft. Worth as well. I would like to propose this to the Board next Monday. Do you have any thoughts?
5. I have had some second thoughts about the role I would play in the expert's meeting. I have begun to think that perhaps it might be better for you to chair the entire program. I will do whatever you wish in this matter, but my inclination is to take a back seat.
6. With regard to your comment last week that I should get your okay before making travel plans, I thought I should let you know that my tentative trip to Stanford next month would be paid for by Stanford -- in case that was a concern. They also offered an honorarium, which I declined.
