Crenshaw.....Dallas Metro Area (?)--Until recently when he retired, was head of surgery at Peter Smith (John Peter Smith?) hosp. at SMU (?) in Dallas Dr. Charles James Carrico.....Dallas Metro (?)--nickname "Jim" Dr. Charles Baxter.....Dallas Metro (?) Nurse Audrey Bell.....Dallas Metro (?) Aubrey Rike.....Highland Park, Texas (a retired policeman now, he was the ambulance driver from Parkland to Love field, and has some personal knowledge of President Kennedy's head wound at Dallas, since he helped put the body in the casket before departing for Love Field) Other Medical Witnesses Selected by Jeremy: Paul K. O'Connor.....Florida (I am almost sure)...perhaps Clearwater (?).
