Transcripts of the depositions of the autopsy doctors are not available right now. They will be publicly available when the Board completes this part of its work relative to the medical evidence. This could possibly be by the end of this year. I will pass along the information that you have provided regarding HSCA transcripts of interviews with medical witnesses to the appropriate staff person for review.  Mr. Smoluk, I understand the ARRB recently interviewed the autopsy doctors. Is the transcript of that interview available? Is there a possibility the Board could interview them again? I ask this because, not having seen the transcript of the first interview yet, I wonder if they were asked about some of the more troubling aspects of the autopsy materials, such as the highly suspect 6.5 mm fragment which now appears in the radiographs. On a somewhat related note, many of the recently released HSCA transcripts of interviews with medical witnesses definitely appear to have been altered. A summary of some of the indications of alteration is presented in Harrison Livingstone's 1995 book KILLING KENNEDY AND THE HOAX OF THE CENTURY, pp. 273-274, 339. I would suggest that the Board study this issue. I believe the evidence is fairly clear that a number of the transcripts were tampered with. Then, the Board could interview those persons who were responsible for the preparation of the transcripts in question. If necessary, the original interviewed witnesses could be reinterviewed and asked about the same issues discussed in the transcripts.
