On a somewhat related note, many of the recently released HSCAtranscripts of interviews with medical witnesses definitely appearto have been altered. A summary of the some of the indications of alteration is presented in Harrison Livingstone's 1995 bookKILLING KENNEDY AND THE HOAX OF THE CENTURY, pp. 273-274, 339. Iwould suggest that the Board study this issue. I believe theevidence is fairly clear that a number of the transcripts weretampered with. Then, the Board could interview those persons whowere responsible for the preparation of the transcripts inquestion. If necessary, the original interviewed witnesses couldbe reinterviewed and asked about the same issues discussed thetranscripts.
