Why, thank you very much for the generous offer. Yes, I would appreciate it if your analyst can get a copy Monday and you could mail it to me. If that doesn't work out please let me know via e-mail and I will go through the regular NARA routine to get it. 2. Its too bad the online NARA database is so out of date. I am a computer programmer who has worked on updating databases containing data on all the electronic equipment on all the Aircraft Carriers in the US Navy, and believe me, given a disk with a list of all the RIFs you have released, it would not be very difficult to write a program which would update the NARA/JFK database based on the data from the ARRB. Some govt. programmers should have figured this out already; hopefully someone has assigned them to this task. 3. a. Also, I have some recommendations for areas where documents are apparently still "referred" and need to be released. Examples: Docs re: LHO "sighted" in Montreal, [many docs involving Canada are referred to the Royal Canadian Mounted Police, and I was wondering if there has been any effort to get the Canadian Government to release them] and several withheld documents pertaining to an informant named Frankhouser who claimed to know LHO. b. What am am asking at this time is what is the proper channel to report these areas that seem to need more attention? Should I send regular US GOVT mail to someone ar ARRB about this or is your e-mail address sufficient to report these items? 5. Unsolicited Recommendation: It would help greatly if the ARRB could have a web page with a continuously updated and complete list of all docs which have been released by you; even if just the RIFs. You can get a web page for \$25/mo. Of course you need a programmer to convert your word processing file listings of released docs to HTML (forgive the "geek-speak"). Having this resource available would mean that when I found a referred doc in the out-of-date NARA database I could check your web page to see if it was released. This would save me the time and trouble of writing to NARA II to check the status and save NARA the time and trouble of writing back, etc. Also, maybe save some time you spend in responding to inquiries such as my last. Just a suggestion. 6. I know all of you there are very busy and I really appreciate all your efforts. Thanks again for your help. I am just trying to discover the truth.
