The Board should ask the CIA for records relating to Claude Barnes Capehart. Researcher David Minier, a Chowchilla, California municipal court judge, had been seeking access to the records, and went through along court action in the matter, losing in July in the U.S. Court of Appeals in San Francisco. According to the article from the San Francisco Chronicle (on the JFK Place web site on Internet), Capehart: 1) was a well driller who moved to Chowchilla, California in 1976 2) told a local Sheriff's Deputy that he had done some work for the CIA 3) an FBI source indicated Capehart had worked on the Glomar Explorer 4) a woman friend who had been seeing Capehart told detectives that he told her he was involved in the Kennedy assassination. 5) Died of a heart attack at age 64 in 1989. Obviously, point 4 is what makes the records assassination records, but in searching for them, I thought the other information might be useful.
