Dear Mr. Byrne, DESTROYED SECRET SERVICE DOCUMENTS. I have forwarded your inquiry to the appropriate staff person and will respond to you in full as soon as I receive the information needed. Thank you for your patience as I await response. Experts Conference: There is not a transcript of the Experts Conference. We received in the past a Freedom of Information Act (FOIA) request for Experts Conference materials, and after extensive research, and in accordance with the JFK Act, withheld certain documents, such as the "follow-up worksheet" you requested. These materials reflect the deliberative process engaged in by the Review Board staff. As I am sure you can appreciate, we are engaged in an inquiry to determine the location of additional records related to the assassination of President Kennedy. At the present time, we need to keep our strategy confidential, although, as you know, all of our records will be sent to the JFK Collection at the National Archives and Records Administration upon our termination. I can provide you with a copy of the agenda for the Experts Conference if that is something that interests you.
