BartholomewI have prepared draft letters for Jeremy as follows:2 drafts of one letter to IRS requesting various information re: LHO's employment;2 drafts of a second letter to Social Security Administration re: LHO's employment;

I do not believe that either letter (to IRS or to SSA) has left our agency yet; the legal considerations are more complex than I realized. Jeremy and Laura are competent to speak on those considerations--I am not. I know Jeremy has contacted Marina Oswald Porter, and asked her to sign a next-of-kin waiver which, if signed, would provide a much higher likelihood of success for our requests. I do not know whether Mrs. Porter has signed the waiver, or not.I am sending Jeremy a copy of this e-mail, because he may want to weigh in on how much you tell the public about these issues at this stage, and how much you don't. In my opinion, the deliberative process is still ongoing, and we are just beginning in this area of LHO's employment and wage records; Jeremy, you may want to provide some advice to Eileen in regard to how much we should reveal at this stage about our initial efforts in this area.We have not taken any action yet, to my knowledge, about the issue of the reportedly missing/confiscated Stripling Junior High School records.
