Wray met with Bosworth to deliver letter notifying

him of recent Board decisions regarding OSD documents. Bosworth also showed Wray approximately 30 new documents recently located by OSD researchers at Suitland. These documents appear to consist almost entirely of material related to correspondence between the HSCA and DOD. The official correspondence between Secretary of Defense Harold Brown, the DOD General Counsel's office, and the HSCA appear to be items already in the HSCA records; the few new items of interest are some internal DOD memos, including a few handwritten notes, regarding DOD compliance with HSCA requests for assistance and information. (There appears to be, for example, a complete set of the correspondence between the HSCA and DOD regarding the lifting of the "silence order" on personnel who attended the JFK autopsy, along with other subjects.) Because many of the documents originated within the DOD General Counsel's office, Bosworth intends to let Stewart Aly review these records before sending them to us. As a separate matter, Bosworth (who is the designated OSD compliance official) said he is currently working on their compliance letter. Don't forget to compose
