	Thom:This seems like Clark did a reversal on the Hosty notes. I don't know if you will have another conversation with him and it probably would not make any difference, but I wish Clark would consider these points:1. For 33 years, it was believed that there were no contemporaneous notes taken during the Oswald interrogation. History was changed with the Hosty revelation that he had, in fact, taken some notes and they still exist.2. Clark is probably correct, there is nothing new in the notes. However, that fact, for many people, will confirm that at least during the time that Hosty was in the interrogation room taking notes nothing contrary to the official history of the questioning happened. Thus, the notes do have importance. Given that Clark is familiar with all of the various theories, including ones that include the lack of a contemporaneous record of the interrogation as being significant, he should appreciate this reality.3. The actual notes are now available for the American public to see and evaluate.
