We have included requests for Veciana's Church Committee testimonies in record requests submitted to the SSCI on two occasions (the last being in a November 1996 meeting with SSCI staff). Despite the recently signed MOU and assurances from new SSCI Staff Director Taylor Lawrence, we have made no further progress in securing additional Church Committee testimony (including Veciana's). The problem continues to be SSCI Security Officer Jim Wolfe, who is responsible for producing the documents. Although he has made many promises and expressed the best intentions, compliance with the JFK Act is obviously very low on his list of priorities. He has failed to return at least three telephone calls from me over the last few weeks, a pattern consistent with our previous experience. The only occasions in which we have been successful obtaining Church Committee records in recent months are those times when we have applied pressure on Wolfe through contacts with other SSCI staffers. I am open to suggestions on how to proceed regarding the testimonies of Veciana or others?
