Per my conversation with David, my understanding is that the cover letter, written statement and answers to the questions for the record should be prepared for delivery to the Subcommittee on Friday, June 27, 1997. Should there be additional action in the Senate on our authorization bill, we will need to update the written statement prior to submitting it on Friday. In light of the action already taken by the House of Representatives this week, the second full paragraph on page 10 should be changed to read the following way:In addition, we are pleased that House Government Reform and Oversight Committee Chairman Dan Burton has introduced H.R. 1553, which would amend the President John F. Kennedy Assassination Records Collection Act of 1992 to extend the authorization of the Assassination Records Review Board until September 30, 1998.
