Hi, You may remember sending me -- about two months ago -- all the testimony that the ARRB has heard. I'm close to getting a web page with all of it online, but wanted to ask you about three things.
1. Can I assume that it is OK to have an e-mail link that allows people to send you e-mail? There is such a link on some other pages, but I wanted to be sure you didn't mind. Who knows, among the "MAKE MONEY FAST!" messages might be somebody with some useful information.
2. Am I allowed to use your logo on my site? My guess is that U.S. government logos are generically in the public domain, but this *does* raise the issue of how I can present my site and not give anybody the impression that it is an official ARRB site. I'll be happy to let you look at my ARRB page before it becomes "public" and give you an opportunity to let me know if you think there is any room for confusion on this point. If I am allowed to use the ARRB logo, is it something you could send me in WMF or EPS graphic format?
3. Do you have a little informational blurb about the ARRB that I could use? Something about the length of a press release, that describes the Board and recaps its activities? If you could send me something I would very much appreciate it. As for the technical stuff: if you can send a blurb and (perhaps) a copy of your logo as attachments to a return e-mail, I can handle that fine on this end.
