He said that he sat down that evening around 6pm & detailed all of his activities that day as well as his injury from the ricocheted round. He finished his accounting of these events around 7pm. I believe he told me about the notebook because he does not view it as an extremely important record, rather it is his only record left.He gave an interview to the FBI and his name was never mentioned in any reports or articles, which he feels is ridiculous. He was returning from the Indianapolis 500 in May of 1964 & decided to take some 16mm film of Dealey Plaza. He believes that the FBI had him under surveillance. When he testified before the WC, they asked him why he was in Dealey Plaza taking pictures & he feels they could only know that if they were watching him. Approximately 4 years after that, his house was ransacked & the 16mm film disappeared. He now has distrust for the government finding the truth.He will consider giving the notebook to the Collection, but "does not feel this is the right time".
