He has now spoken with the key CBS person on this matter in New York, Vice President Linda Mason. According to Ortiz, Mason is inclined to be responsive to our request. He suggested that a meeting in New York with our representatives, Mason, the head of the CBS Archives and him, would be the most effective way to pursue this matter. Ortiz has suggested a meeting in New York sometime around October 7th. He will get back to me with more specifics about a meeting date, but I wanted to see if it would be possible for you to go to New York with me for this meeting around the 7th. Please advise me what your schedule looks like and then we can nail down the specific time and date with Ortiz.I would like to note that I have not specifically mentioned our interest in outtakes at this point. My references have been general such as "all materials that are relevant to the assassination." I think talking about outtakes at the outset would immediately taint our request and any future discussions. Thus, I hope to make progress on the on-air materials, further establish our credibility and then deal with the tougher issues like conditions of a donation and outtakes. As a result of my conversations with Ortiz today, I will put Jack's letter to the CBS News President on hold again.
