Additional information on 1.:These are records in the SCIF that were received from the JFK Library and are awaiting action. They have not been reviewed in detail because they have been caught in the transition involving my responsibilities and Michelle's. As previously reported in JFKL status memos, this group of documents includes documents that have not been reviewed by the relevant agencies yet. I told the Library that the Board would seek to expedite the review and release through us working with these agencies. In other instances, there are redactions taken long ago, but it is likely that they can now be opened. Again, our contacts with the relevant agencies will hopefully help to expedite the review and release of records. I have to devote time to these documents and intend to seek Michelle's counsel on them. Additional information on 2.: This estimate is based on what Library staffers have told me. The Library is still working through their problems with the disk. Thus, they cannot give an exact number on what remains to be reviewed.
