 On Gemberling & other FBI retirees -- if you need his address or phone number -- you may want to just call Carol at 324-0671 and get the addresses & phone numbers from her. She has the retired agents phone book in her top desk drawer. Her information tends to be more accurate (and maybe easier to obtain) than information from FINCEN. Also -- on a more substantive note about interviewing Gemberling -- if you are going to do a short phone interview of Gemberling, you might want to consider calling the other Dallas/FW former agents that Hosty mentioned in his interview as equally important sources of information, including John Fain (who is old, but alive, and handled the Oswald case before Hosty), Wally Heitman (who was the only Spanish speaking security agent in Dallas and, thus, handled all of the Cuban cases -- Hosty thought he would be the best source of information for us), SA Bookhout (who was one of three agents who Hosty says would have heard a tape of Oswald in Mexico City if anyone at the FBI ever heard such a tape), Bardwell Odum (may be dead, but Hosty says might remember Shanklin's instructions to Hosty to destroy records), and Manning Clements (who was Gemberling's counterpart, as he headed the Ruby section of the post-assassination investigation in Dallas).
