Date:10/20/97Subject:Church Committee RecordsSummary of the Call:On 10/16/97, I called Mr. Wolfe to follow-up on Jeremy Gunn's conversation with Staff Director Taylor Lawrence. Mr. Wolf confirmed that the Committee will be making copies (from microfilm) of the Church Committee testimony that we had identified in our Sept. 19, 1997 letter to the Committee. (Mr. Wolf was perplexed that many of these materials cited in the JFK Report of the Church Committee were not captured through the review of the hard copy files, which Mr. Wolf said comprised 400 boxes; I told Mr. Wolf that we needed to determine where the hard copy materials are that pertain to the Schweiker/Hart work for the Church Committee since there may be other relevant materials or testimony that is not identified in the JFK Report). In addition, they will be making available to us their notebook(s) identifying with highlighting those Church Committee materials that have been redacted so that the Review Board can vote on the redactions. With respect to an index of Church Committee materials, Mr. Wolf said there is a multi-volume log that records all documents logged by the Committee. For each document, this log identifies the date received, the log no., the person or organization sending the document, and (for testimony) whether it is executive session testimony. The subject or content of the document or testimony is not identified. I told Mr. Wolfe that we may want to inspect this log. Mr. Wolfe said his priority would be to transmit to us the copies of the testimony that we identified and, thereafter, to address the issue of whether there may be additional assassination-related records that have not been identified or located.
