 Summary of the Call: Dr. Guinn called in response to our December 12, 1997 letter to him requesting that he make available to the Review Board all papers in connection with his work on the HSCA. Dr. Guinn stated the following: (1) He does not have the magnetic tape regarding the analysis he had done for the HSCA; he believes that it was discarded when he moved from California in 1981 and (2) the other materials he has are publicly available or were turned over to the HSCA. For instance, he has: FBI materials made available to him under FOIA; a copy of the report he submitted to the HSCA; published papers; and background studies on the Mannlicher-Carcano rifle. My sense is that Dr. Guinn does not have any unique, primary materials relating to his work for the HSCA. However, I asked Dr. Guinn (and he agreed) to list the materials he has in a formal letter to the Review Board, and we would thereafter decide if we want to obtain copies of any of the materials.
