Summary of the Call: Toni Bowie of the Army Declassification Activity (ADA) called me this date to request an extension on the deadline in our December 8, 1997 letter, which requested the Army provide evidence by January 16, 1998 in support of desired postponements in an Alpha-66 document--a two-page letter from the Army to SECDEF about Army contacts with an anti-Castro terrorist group. She said that the letter had been sent over to DCSINT (Deputy Chief of Staff for Intelligence) by ADA for preparation of a formal response, and that DCSINT had agreed to do so, but that the action officer within DCSINT had just been given the assignment today, and there was no way a formal response to our letter could be staffed, chopped, and in our hands at the ARRB by C.O.B. tomorrow. I agreed. Previously I had told Ms. Bowie that if an extension was requested for preparation of a response, that we would favorably consider a one-time extension request. Therefore, I granted a one-time extension to the ADA until C.O.B. February 9, 1998 for submission of evidence in support of this document. My intention is to place the issue before the Board at the February 17 Board Meeting, one way or another.
