	transcripts that he previously sent which we did not request and which are at NARA. I told him that, in the
	future, if he identifies transcripts not on our request list, then he should call me and I can check whether they
	are at NARA or whether we simply failed to identify these. He agreed to do this. Mr. Wolfe indicated that Mr.
	Lawrence has specifically instructed him to prepare a letter addressing the status of matters in light of our
	2/10/98 letter stating that we are concerned that the SSCI will not finish its work onder the JFK Act by Sept.
	1998. Wolfe said this may delay the next shipment of records because Taylor Lawrence is out this week. I
	asked Wolfe who supervised the initial search for JFK records of the Church Committee. It was former Staff
	Director Charles Battaglia, who is now the Staff Director for the Senate's Veterans Affairs Committee. I would
	like to call Battaglia to see if he can give us any insight on why so many transcripts cited in the JFK Report (i.e.,
	the Hart Schweiker materials) were not initially identified in the initial SSCI review done of hard copy records,
	and whether he can identify for us any indices to Church Committee records in storage that he utilized.
