When you get the Act, see 9(f): Reports by the review board. 9(f)(2) says that the Review Board's first report (to the folks listed in 9(f)(1)) "shall be issued on the date that is 1 year after the enactment of [the JFK Act] and subsequent reports every 12 months thereafter until termination of the Review Board.And 3 -- I think the cite is 44 U.S.C. 2201 et seq.but I'm not sure about the date of the current U.S. Code volume, so Chris might actually need to check it. (You do mean the whole Presidential Records Act and not just the Nixon Records Act (actually -- the Presidential Recordings and Materials Preservation Act), right? I DO have the cite for the PRMPA if you need it. If you have the internet at home, you can check it on a site called "FindLaw," which has links to all the U.S. Code. Sorry to deluge you with info. Send me more questions if you have them!
