The HSCA had several folders' worth of files that I believe they got directly from DPD (as opposed to, say, WC files). I don't remember where they're located in the HSCA collection, other than that I believe they are in the earlier numbered boxes. Tom Samoluk also dealt directly w/DPD, I think, early on in the Review Board's existence and would know if we got a separate (non-HSCA) slug of DPD records (Jeremy may remember this, too). I'd probably do a search on DPD (or some rendition thereof) and see if you get a bunch of HSCA references that are mainly bunched in one or a small number of HSCA boxes, and start there. Now, I don't know whether NARA has the actual address book, though I presume they do. Warren Commission files might also contain copies of the book, though whether any WC copies would have been a copy of the DPD copy, or whether they would have had an FBI copy of the address book, I don't know. Marion Johnson's/NARA's Inventory of the Records of the President's Commission on the Assassination of President Kennedy (1973) says Oswald's address book and/or some facsimile of is filed in "INV,3-6" of the WC records. Steve Tilley could find it for you if you wanted to check out the WC's version. I don't know what Commission Document (CD) or Commission Exhibit (CE) the address book is for sure, but it might be CE 18. You might want to run a search on "CE 18" as well and see what you get. Hope I've understood your question properly; if not, let me know! While I've got you, can you make a quick check on something for me? Could you see if the Warren Commission's 26 volumes (not the Report itself) has an index of any sort. I read somewhere it doesn't, then I read it has a name index only (as opposed to a subject index). I think the latter is probably accurate, but it would be good to know for sure. Thanks.
