r apologize for the companiti before rgo into an the details below, I want to let you know that we are scheduled to present the final report to Congress at 2:00 on Tues. Sept 29th, in 2203 Rayburn (room sponsored by Congressman Burton.) Earlier this week we decided to move forward on planning three events, one at the White House, one on the Hill, and one at the National Archives. We decided to try to set something up at NARA on the morning of Tues. Sept. 29, something on the Hill that afternoon, and wait to see what we hear from the White House. I later spoke with Susan Cooper at the Archives, and she made the following point -- the Congress and the White House may feel slighted if we were to first present the final report to NARA (and the press.) Jack was still here and I relayed that to him, and we agreed that we should at least attempt to present the report in this order: White House, Congress, NARA. With the hope that we could do this in that order, I tried to arrange for an afternoon event (3:00) at NARA in the Archivist's reception room, leaving time earlier in the day for the White House and Congress.
