ALSO WOULD LIKE CONSIDER MAKING TERMINAL PAYMENT TO WIDOW AMGLAD-1 INSTEAD OF CONTINUING MONTHLY SUBSIDY THRU AMGLADS. ADVISE AMOUNT SHE RECEIVING AND YOUR VIEWS BEST WAY HANDLE THIS MATTER.
