Report of Conversation with [REDACTED] 12 August 1955.

1. The writer talked to [REDACTED] at his office at [REDACTED] between 2:45 and 4:00 PM, Tuesday, 2 August 1955. [REDACTED] permitted the writer to briefly examine certain secret material described below and discussed much of the contents therein. Details follow:

Apparently the [REDACTED] has not yet completed its study and approval for release has not yet been issued.

[REDACTED]  
According to [REDACTED] this should be done in the very near future. Only twenty-one copies of the [REDACTED] are in existence and CIA is not on the list. [REDACTED] urged [REDACTED] to obtain as soon as possible after release since he feels much of the material is of importance to us.

This [REDACTED] apparently is the reference material and the supporting documents for the [REDACTED]. There are thirty-one copies only and none were issued to CIA but six or more were issued [REDACTED]. [REDACTED] thinks we could borrow one of these for examination if efforts were made to obtain it.

d) Discussion relative possible establishment of Board of Inquiry in CIA -- The writer informed [REDACTED] that [REDACTED] made a report to the Director of Security after conferences with [REDACTED] and other [REDACTED] during the past several weeks and had recommended that a Board of Inquiry be set up in the Central Intelligence Agency to handle returnee cases--primarily [REDACTED] but capable of taking up any future problems along these lines. The writer stated that this report in general had been concurred in by [REDACTED] and a strong possibility existed that this plan would be approved by the DCI after having been carried through the usual internal channels to him. Thereupon, [REDACTED] kindly offered his services as special consultant to this Board. [REDACTED] pointed out that he had very unusual knowledge of the problem, had worked in developing [REDACTED]

in these matters and was on the [redacted]  
which prepared reports referred to in Section a) above.  
He also stated he would have access to [redacted] information  
which he thought would be extremely valuable. The writer  
thanked [redacted] and stated he would refer
