
Dear Mr. Greenewald:

This responds to your request of 19 March 2018 to have 18 pages of classified material on the subject of Mother Teresa reviewed for declassification. The material you requested has been reviewed and those portions responding to your request are currently and properly classified in accordance with E.O. 13526. They meet the criteria for classification as set forth in Section 1.4 subparagraphs (c) and (d) and remain classified TOP SECRET and SECRET per Section 1.2 of E.O. 13526 for material less than 25 years old. The material older than 25 years is exempt from automatic declassification per section 3.3 subparagraphs b (1), (3) and (6). In addition, Section 3.5 (c) of E.O. 13526 allows for the protection of information under the provisions of law. Therefore, information that would reveal NSA/CSS functions and activities has been protected in accordance with Section 6, Public Law 86-36 (50 U.S. Code 3605, formerly 50 U.S. Code 402 note). Portions that do not respond to your request are marked as Non-Responsive and, as such, are not subject to appeal.

Since your request for declassification has been denied you are hereby advised of NSA's appeal procedures. Any person denied access to information may file an appeal to the NSA/CSS MDR Appeal Authority. The appeal must be postmarked no later than 60 calendar days after the date of the denial letter. The appeal shall be in writing addressed to the NSA/CSS MDR Appeal Authority (P133), National Security Agency, 9800 Savage Road, STE 6881, Fort George G. Meade, MD 20755-6881. The appeal shall reference the initial denial of access and shall contain, in sufficient detail and particularity, the grounds upon which the requester believes the release of information is required. The NSA/CSS MDR Appeal Authority will endeavor to respond to the appeal within 60 working days after receipt of the appeal.


(A) ACCORDING TO PRESS (UNCLASSIFIED), THE "PEACE BOAT," REGISTERED UNDER THE NAME IBN KHALDOUN, WAS TO LEAVE ALGIERS ON 5 DECEMBER EN ROUTE TO IRAQ TO DELIVER MILK AND MEDICINE TO IRAQ'S CHILDREN. THE BOAT WAS TO MAKE CALLS AT SEVERAL PORTS ALONG THE ROUTE. THE MISSION WAS BEING CONDUCTED AT THE INITIATIVE OF THE CONFERENCE OF ARAB WOMEN FAVORING IRAQ. APPROXIMATELY 300 WOMEN *WERE TO TRAVEL ON THE BOAT, INCLUDING MOTHER TERESA.


