This is in response to your request dated and received in the National Reconnaissance Office (NRO) on 20 June 2018. Pursuant to the Freedom of Information Act (FOIA), you requested **"all documents created during the processing of FOIA Request number F-2016-00130, along with all of those created during the processing of my subsequent FOIA appeal"**

Your request has been processed in accordance with the FOIA, 5 U.S.C. § 552, as amended. A thorough search of our files and databases located forty-seven documents responsive to your request. Twenty-six documents are being released to you in part. The remaining twenty-one documents are being denied to you in full.

Material withheld from release is denied pursuant to FOIA exemptions:

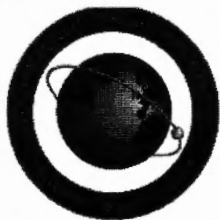
(b) (1) as properly classified information under Executive Order 13526, Section 1.4(c);

(b) (3), which is the basis for withholding information exempt from disclosure by statute. The relevant withholding statute is 10 U.S.C. § 424, which provides (except as required by the President or for information provided to Congress), that no provision of law shall be construed to require the disclosure of the organization or any function of the NRO; the number of persons employed by or assigned or detailed to the NRO; or the name or official title, occupational series, grade, or salary of any such person;

(b) (5), which applies to information that is predecisional and deliberative in nature; and

(b) (6) Which applies to records which, if released, would constitute a clearly unwarranted invasion of the personal privacy of individuals.

This is in response to your request dated 16 August 2016 and received in the National Reconnaissance Office (NRO) on 17 August 2016. Pursuant to the Freedom of Information Act (FOIA), you are requesting **"a copy of the NRO Congressional Budget Justification Book for Fiscal Year 1996."**

We have accepted your request. It will be processed in accordance with the FOIA, 5 U.S.C. § 552, as amended.

Since we may be unable to provide a response within the 20 working days stipulated by the Act, you have the right to consider this a denial and may appeal on this basis to the NRO Appellate Authority, 14675 Lee Road, Chantilly, VA 20151-1715 after the initial 20 working day period has elapsed; doing so, however, would exhaust your administrative appeal rights. To preserve these rights, we recommend that you allow us sufficient time to continue processing your request and respond as soon as we can. You will then have the right to appeal any denial of information after you receive a final response from us. Unless we hear otherwise from you, we will assume that you agree and will continue processing your FOIA request on this basis.

The FOIA authorizes federal agencies to assess fees for record services. Based upon the information provided, you have been placed in the "educational/scientific/media" category of requesters. Requesters in this category are generally responsible for duplication fees (\$.15 per page) exceeding 100 pages. We will notify you if it appears that we will reach or exceed our \$25.00 minimum in processing your request. 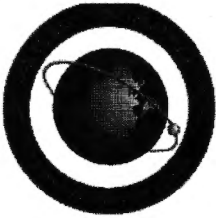

This is in response to your request dated 16 August 2016 and received in the National Reconnaissance Office (NRO) on 17 August 201. Pursuant to the Freedom of Information Act (FOIA), you requested "a copy of the NRO Congressional Budget Justification Book for Fiscal Year 1996."

We have processed your request in accordance with the FOIA, 5 U.S.C. § 552, as amended. We located the record responsive to your request; however, after thorough review, we determined that the record must be denied in full pursuant to the following FOIA exemptions: (b)(1), as properly classified information under Executive Order 13526, Sections 1.4(c), (e), and (g); and (b)(3), which is the basis for withholding information exempt from disclosure by statute. The relevant withholding statute is 10 U.S.C. § 424, which provides (except as required by the President or for information provided to Congress), that no provision of law shall be construed to require the disclosure of the organization or any function of the NRO; the number of persons employed by or assigned or detailed to the NRO; or the name or official title, occupational series, grade, or salary of any such person.

Additionally, the information meets criteria specified in 1.7(e) of Executive Order 13526 that a series of unclassified items in the document in the aggregate reveal associations or relationships not otherwise revealed in the items individually, and these aggregate associations and relationships meet the standards for classification and are not otherwise revealed in the individual items of information.

You have the right to appeal this determination to the NRO Appellate Authority, 14675 Lee Road, Chantilly, VA 20151-1715, within 90 days of the above date. 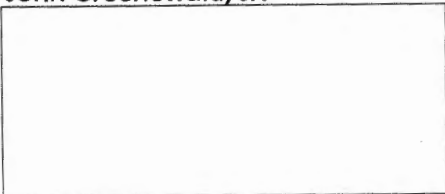

This furthers the proof there should be at least some releasable portion of the document.

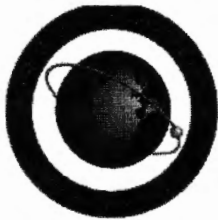

Dear Mr. Greenewald:

This is in response to your faxed correspondence dated and received in the National Reconnaissance Office (NRO) on 18 April 2018. Pursuant to the Freedom of Information Act (FOIA), you are appealing the NRO's initial determinations on these cases:

**F-2016-00130** - Request for a copy of the NRO Congressional Budget Justification Book for Fiscal Year 1996; and

**F-2017-00088** - Request for a copy of the Congressional Budget Justification for FY 2018.

We have accepted your appeals. We will notify you when the NRO Appellate Authority makes a determination regarding each appeal. In the event that we are unable to provide a determination within the 20 working days stipulated by the FOIA, you have the right to consider this a denial of your appeal, and may seek a judicial review in a United States District Court in accordance with 5 U.S.C. § 552, as amended. To preserve your administrative appeal rights, however, we recommend that you allow us sufficient time to continue processing your appeals and respond as soon as we can. You will then have the right to contest any adverse determinations after you receive the final Appellate Authority determinations from us. This is in response to your faxed correspondence dated and received in the National Reconnaissance Office (NRO) on 18 April 2018. Pursuant to the Freedom of Information Act (FOIA), you are appealing the NRO's initial response to your 16 August 2016 request for **"a copy of the NRO Congressional Budget Justification Book for Fiscal Year 1996."**

As the NRO Appellate Authority, and after a thorough review of this case, I am upholding the NRO's initial determination that the responsive document must be withheld from release in its entirety pursuant to the following FOIA exemptions: (b)(1), as properly classified information under Executive Order 13526, Sections 1.4(c), (e), and (g); and (b)(3), which is the basis for withholding information exempt from disclosure by statute. The relevant withholding statute is 10 U.S.C. § 424, which provides (except as required by the President or for information provided to Congress), that no provision of law shall be construed to require the disclosure of the organization, or any function of the NRO; the number of persons employed by or assigned or detailed to the NRO; or the name or official title, occupational series, grade, or salary of any such person.

Additionally, the information meets criteria specified in 1.7(e) of Executive Order 13526 that a series of unclassified items in the document in the aggregate reveal associations or relationships not otherwise revealed in the items individually, and these aggregate associations and relationships meet the standards for classification and are not otherwise revealed in the individual items of information.

You are advised that you are entitled to a judicial review of this determination in a United States District Court in accordance with 5 U.S.C. § 552, as amended.


