Dear Mr. Greenewald:

This responds to your Freedom of Information Act (FOIA) request of 24 August 2014 for "All records, electronic or otherwise, that were generated for FOIA case #73445 and MDR #73494. This would include, but not limited to, emails, letters, memos, inter-agency communications, etc." Your request was received on 25 August 2014, and has been assigned Case Number 78914. For purposes of this request and based on the information you provided in your letter, you are considered an "all other" requester. There are no assessable fees for this request.

We have completed our search for records responsive to your request, and some of the material is enclosed. This Agency is authorized by statute to protect certain information concerning its activities, as well as the names of its employees. Such information is exempt from disclosure pursuant to the third exemption of the FOIA, which provides for the withholding of information specifically protected from disclosure by statute. The specific statute applicable in this case is Section 6, Public Law 86-36 (50 U.S. Code 3605). We have determined that such information exists in these records, and we have excised it accordingly.

Since these deletions may be construed as a partial denial of your request, you may appeal this decision. However, as your case processing is not yet fully completed, our appeal procedures will be provided with our final response letter.

The remaining material responsive to your request requires further review prior to release and has been placed in the first-in, first-out processing backlog queue. Please be aware, there are a significant number of cases ahead of yours in the backlog queue. We appreciate your patience with our efforts to treat all requesters fairly by responding to each on a "first-in, first-out" basis. The National Security Agency/Central Security Service (NSA/CSS) is the nation's cryptologic organization, and we have a twofold mission. Our Information Assurance mission is to provide solutions, products, and services to protect U.S. information infrastructures critical to national security interests. In response to requirements set at the highest levels of government, our Signals Intelligence mission is to collect, process, and disseminate intelligence information from foreign signals for national foreign intelligence and counterintelligence purposes and to support military operations.

Please be advised that "UFO's," "extra-terrestrials," and "paranormal activities" do not relate to NSA's mission. NSA documents that have been located in searches for "UFO" documents generally fall into two categories. The first category of records includes foreign intelligence reports that contain words such as "unidentified aircraft" or "unidentified (flying) object" or the like. These are simply terms that are used to describe conventional aircraft or objects (possibly weather balloons) that have not been identified as such at the time of the report. The second category of "UFO" documents includes items written by NSA employees with an interest in UFOs or open source publications (magazine/newspaper articles) that were placed into "agency" files by employees. These records are subject to the provisions of FOIA only because they became "agency records" once they were placed in official agency files.
